RCD Program Updates:

- **Urban Streams Coordinator** The USC coordinated and implemented another plant propagation class, the fourth one held in 2016 (free and open to the public in partnership with Pt. Reyes Seashore, its Association and recently with SPAWN as a new collaborator). The USC has been conducting electro-fish training with the Marin Municipal Water District. This training supports hours required by the National Marine Fisheries Service to obtain a Section 10 permit. The Tomales Bay Watershed Council's State of Tomales Bay Conference was supported by the USC through the creation of the flyer and assistance before and during conference day. USC is preparing for two creek clean-ups in early October; one in Sleepy Hollow and the other in Kentfield in addition to the final plant propagation class for 2016.
- **Finance Committee:** A new meeting is pending Terry's return.

- **Marin Carbon Project** Four carbon farm plans are in progress and will be completed by the end of October. A rangeland carbon farm plan template is currently under review by NRCS partners. RCD staff presented at the CA Adaptation Conference.
- Black Mountain Roads Tasks remaining: fencing and minor erosion control work.
- Americano Creek Watershed Gold Ridge RCD is proceeding with carbon farm planning.
- **Conserving Our Watersheds:** Three projects were completed. One project is underway. Four are planned to start in October.
- Media/Outreach: None.
- **Grant Proposals:** Staff is currently writing a proposal with Sonoma RCD to the EPA/State Water Board Clean Water Act program that will assist the Tomales Bay and Sonoma Creek dairies in carrying out projects to comply with the Dairy General Order. Dairies in these watersheds are selected because they are within priority watersheds of the State. RCD staff is pursuing two additional grant proposals in the next month. CA Association of RCDs is seeking funding to compliment the Healthy Soils Initiative/Carbon Farming programs.

- **District:** Board and staff attended the State of the Bay Conference! We are now interviewing for a Rangeland Specialist position. Staff are now closing books for the fiscal year. Audit will be conducted this month.
