# **RCD Program Updates:**

- **Urban Streams Coordinator** Throughout the last three months the USC juggled electrofishing monitoring training with MMWD, implemented a restoration project, planed for collaborative workshops in 2017, lead a creek clean-up event, conducted four site visits and presented to a variety of audiences. USC also attended a workshop to learn more about rainwater harvesting, hands-on, for larger systems. To learn more about Sarah's recent adventures, please review the USC Board Report
- **Finance Committee:** A new meeting will be scheduled for January.
- Marin Carbon Project Four carbon farm plans are in progress and will be completed by the end of December.

- Black Mountain Roads Tasks remaining: fencing and minor erosion control work.
- Americano Creek Watershed Gold Ridge RCD is proceeding with carbon farm planning.
- **Conserving Our Watersheds:** Eight (8) projects are complete! One project is underway (a fence); 3 plantings are scheduled for winter; three (3) project will start in 2017.
- Media/Outreach: None.
- **Grant Proposals:** Staff is currently writing a proposal with Sonoma RCD to the EPA/State Water Board Clean Water Act program that will assist the Tomales Bay and Sonoma Creek dairies in carrying out projects to comply with the Dairy General Order. Dairies in these watersheds are selected because they are within priority watersheds of the State. RCD staff is pursuing one additional grant proposal in the next month. CA Association of RCDs is seeking funding to compliment the Healthy Soils Initiative/Carbon Farming programs in addition to establishing an RCD funding program.

  - \$200K. State Coastal Conservancy. Carbon Farming. Pending
- **District:** After a very thorough interview process, it was decided that a rangeland specialist would not be hired at this time. The fiscal audit is near completion. RCD staff attended the annual CA RCD conference.
