RCD Program Updates – 45 min:

- **Marin Permit Coordination Program Renewal** The PCP Administrative Project Description is under review and edit by Marin RCD's partners.
- **Urban Streams Program:** One site visit was conducted in Fairfax related to creek bank erosion and 18 stakeholders were assisted or supported with resources and answers to their questions. The first of six free native plant propagation classes was held on May 20th at the Bear Valley Visitor Center's Red Barn Classroom to learn about Integrated Pest Management, pollinators and habitat-gardening. As well, USC with Friends of Corte Madera Creek Watershed group, College of Marin and Marin County's Flood Control Department came together to conduct restoration at the school's Lot 15 area along Murphy Creek.
- **Finance Committee:** No report.
- **Marin Carbon Project** 4 carbon farm plans are complete. 5 are underway. All will be complete by end of July. One tour was provided for the Seed Foundation.
- **Dairy CARES**: Staff is completing a series of maps for seven dairy producers to assist with compliance with the Dairy General Order located in the SF Bay Region. The General Order for the North Coast Region is expiring and public meetings will be held in the near future
- **Americano Creek Watershed** The Valley Ford Cheese Company rainwater catchment project continues to move forward and Gold Ridge RCD will be hosting a bid tour on Friday, June 30th at 10 am. The Pond Bot project has been submitted to CA Dept. of Food and Ag for consideration.
- **Conserving Our Watersheds:** One riparian fence was completed. One water development will begin soon. Two Requests for Cost Proposals went out to bid. Twelve new projects were evaluated; projects are presented as an action item at this board meeting.
- **Media/Outreach:** RCD staff provided Clean Water Act budget information to Marin Conservation League, Indivisible West Marin and Bay Nature Magazine
- **Grant Proposals:** The Urban Streams Coordinator (USC) submitted proposals to CA Dept of Fish & Wildlife's Fisheries Restoration Grant Program and State Coastal Conservancy Prop 1 to implement two Landowner Assistance Program projects.
 - \$25,902k. North Bay Watershed Association. Awarded!
 - o \$195k. CA Dept. Fish and Wildlife San Geronimo. *Pending*
 - o \$152k. CA Dept. Fish and Wildlife Walker Roads. *Pending*
 - \$239,994. State Coastal Conservancy San Geronimo. Pending
- **District:** Staff provided a presentation on the Marin RCD's Permit Coordination Program to the North Bay Watershed Association. Staff attended the County's Annual Ag Summit.
- **Landowner Requests:** Staff received 23 requests for assistance in February (4 agricultural and 19 urban landowners)
