RCD Program Updates (See staff report for details):

- Drought News- A time for updates from all attendees. Check out our drought page https://www.marinrcd.org/drought-assistance/
- Conserving Our Watersheds Program: Possible Fee for Service Agreement to apply for permit assistance. Grant extension granted. 3.5 out of 5 sites completed! Two projects to be built in 2021.
- Messaging/Outreach/Education:
- Urban Streams Program: USC attended several meetings including the Lagunitas TAC subcommittee meeting on Marin Water's flow release schedule, SF Estuary Partnership's Blueprint update meetings, and meetings regarding permitting pond maintenance activities. Sarah attended Salmonid Restoration Federation's Coho Confab (mini conference) on the Navarro River in Mendocino to tour various restoration projects focused on coho habitat enhancement. Finally, Sarah has attended all of the focused stakeholder group meetings with CDA and consultants regarding the roll out of the draft expanded SCA Ordinance for San Geronimo Valley. The team held their final focus group meeting on August 30th. Public draft will be released for review on September 7th.
- Carbon Farming Program: Wildlife Conservation Board: CFP designs will be worked on from now to April 2022, in the order of project ranking. First site visit at Torliatt complete and designs submitted for implementation funding through NRCS CIC program. Chileno Valley Ranch CFP underway. Educational materials: wildlife-friendly hedgerow pamphlet final edits underway, and translation in October. Expected to be published by the end of the year. Department of Conservation-Stemple Creek Restoration: Fence designs complete with NRCS and provided to landowner and USFWS. Site visit complete to update design at eastern-most cross-fence and soon to be submitted to USFWS. CDFA Healthy Soils Application Assistance Grant awarded (\$59K), meaning 21-22 round will likely occur. General: A "Funding for Carbon Farming Implementation" spreadsheet has been created. Find here. Training for Board and staff by the Federated Indians of Graton Rancheria is booked for Nov 18 from 1-2:30 PM. Mark your calendars and email michelle@marinrcd.org for login details.
- Walker Creek Watershed: Sarah has continued to stay in touch with the grant manager
 to find a time to discuss this request for an extension on the project term and additional
 funds. Sarah will work with the lead consultant at PCI to develop a revised schedule,
 scope of work, and budget to accommodate two changes; 1) the lack of data on water
 surface elevation due to a poor winter/rainy season and 2) the outcome of the first TAC
 meeting resulted in a desire for a more robust and engaging TAC process (which will cost
 more).
- Pine Gulch Creek Project: Coho salmon were seen in Pine Gulch creek! This project is
 helping provide them with higher quality instream habitat! Peter's pond bottom is not
 completely sealed and therefore is leaking! Peter is seeking funding to apply bentonite
 to pond embankments. Dennis' pond has a leak in the overflow line, and he is fixing it.
- Grant Opportunities:
 - o The RCD has received the first of an annual contribution (\$3,000) from an endowment which will be used to support interns with on the job training. RCD staff will be discussing how to integrate it into our programs.

- o Staff will be working on a scope of work and budget for our \$1M carbon farming proposal in preparation for State Coastal Conservancy approval in December.
- o The Water Board notified staff that future priorities for 319(h) have been expanded to include high quality waters including Drakes Estero and the Point. This means future funding could help the dairies that drain into the Pacific Ocean!
- **Finance Committee:** The Finance Committee met and reviewed the FY 21/22 Draft Marin RCD Annual Budget, MALT Stewardship Agreement, and FY 20/21 Audit.
- District: Darrylin is working on the FY2122 Draft Budget, onboarding new staff, comparing payroll companies, creating new spreadsheets and balancing all numbers across the organization for the new Fiscal Year. Darrylin met with CPA to review FY2122 numbers in preparation for the annual Audit. Darrylin has been working with Nancy to analyze Bay Area salaries and benefits in preparation for revisions to the RCD Step Schedule.
- New landowners/stewards assisted: Ag: 11 total 6 with technical assistance; 1 with outreach; 1 requested CFP and put on waitlist; 3 with funding. Urban: 8 total; 8 assisted with information only, 0 site visits, 3 total educated.

INFORMATIONAL ITEMS

- 4. Presentations & Updates:
 - USDA Natural Resources Conservation Service Nick Goodman shares EQIP CIC app
 deadline today with ranking to be complete by the middle of August. NRCS has received 40
 Applications for this program with a focus on drought needs. NRCS staff change will
 included the addition of an Archeologist this summer. This should expedite cultural
 resources reviews.
 - Marin Agricultural Land Trust/SAP Eric Rubenstahl mentions MALT's working with Nancy Scolari (MRCD) to reformat Landowner Assistance Program. MALT Board has approved \$250,000 in SAP funding, plus additional Drought Assistance funding. Meeting with a consultant on Conservation Priorities.
 - Students & Teachers Restoring a Watershed Isaiah shares they have successfully irrigated all their plants, despite the drought. Now pivoting to the next season including Straus Home Ranch and Lazy R project. Also working with SRCD on two projects: Terra Firma and Eames Foundation.

RCD Program Updates (See staff report for details):

- **Conserving Our Watersheds Program:** Possible Fee for Service Agreement to apply for permit assistance. Grant extension granted. 3.5 out of 5 sites completed! Two projects to be built in 2021.
- Messaging/Outreach/Education: Check out our drought page https://www.marinrcd.org/drought-assistance/
- **Urban Streams Program**: USC attended several meetings including the June Lagunitas TAC meeting. USC carried out two (2) site visits, one in SGV to carry out a bird nesting survey prior to tree trimming along the creek and one in Novato with Marin County's stormwater program and the police department staff. USC attended the first CDFW North Coast Coho Project meeting specific to guiding future restoration efforts in Lagunitas Creek. Finally, Sarah has attended ongoing meetings with CDA and consultants regarding the roll out of the expanded SCA Ordinance for San Geronimo Valley.
- Carbon Farming Program: Wildlife Conservation Board: CFP design will be worked on from now to April 2022, in the order of project ranking. First site visit at Torliatt complete. Chileno Valley Ranch CFP underway. Educational materials: wildlife-friendly hedgerow pamphlet layout is being finalized. Expected to be published by the end of summer. Department of Conservation-Stemple Creek Restoration: Fence designs complete with NRCS and provided to landowner and USFWS. A "Funding for Carbon Farming Implementation" spreadsheet has been created. Find here.
- Walker Creek Watershed: The lead consultant at PCI has been out of town and has now returned and is working with Sarah to develop a revised schedule, scope of work, and budget to accommodate two changes; 1) the lack of data on water surface elevation due to a poor winter/rainy season and 2) the outcome of the first TAC meeting resulted in a desire for a more robust and engaging TAC process (which will cost more).
- Pine Gulch Creek Project: 5-year post-construction monitoring reports are due; Marin RCD secured an extension from the Army Corps of Engineers and Water Board to submit all final reports. Marin RCD hired SFEI to complete CRAMs, farmers hired PCI to complete wetland

delineations, and Marin RCD monitored the riparian enhancement area. The riparian enhancement area has 75% survival; we met the goal of 60 plants alive and thriving! The majority of plants look healthy and vigor with most over 3 ft tall with several being at least 10 ft tall. Other reports include the Riparian Enhancement Area and Notice of Completion. Peter's pond still leaks! Peter is seeking funding to apply bentonite to pond embankments.

• Grant Opportunities:

- Shared Forester. Gold Ridge/Sonoma/Marin are partnering in a shared forestry position. The proposal is submitted to the National Association of RCDs. *Pending*
- **Finance Committee:** The Finance Committee met and reviewed the draft annual budget which will be presented at the August meeting. The Salary Step Schedule is being revised pending bay area salary and retirement research.
- **District:** Darrylin is in the final stages of the FY 19-20 Annual Audit (Delays on the Auditor's side due to COVID), working on the FY2122 Draft Budget, comparing payroll companies, getting a Kaiser quote for a MRCD Group plan and meeting with a Financial Advisor to learn more about 401K investments for staff retirement savings. Hopefully arranging a Financial Advisor to come out and meet with staff.
 - The Fiscal Year closed on June 30 so Darrylin is invoicing all funders to wrap up FY2021. Staff met to discuss the production of the aforementioned 2022 calendar. The result of the meeting was a shift to produce a "Planner" instead of a calendar. Darrylin is working on a one month draft of the Planner. Upon completion staff will be called in to review.
- New landowners/stewards assisted: Ag: 8 total 0 requested CFPs and put on waitlist, 2 with drought assistance, 6 with other technical assistance. Urban: 12 total 12 assisted with information, 2 via site visits, 4 total educated.
