• **Media/Messaging/Outreach/Education**: "Marin study to explore new ways to use biomass" Marin IJ. "Marin carbon projects to receive major federal funding" PR Light with help from George!

- **Drought News:** The Sonoma and Marin Drought Resiliency Report is nearly complete.
- Justice Equity Diversity Inclusion: This work will begin in 2023.

• **Biomass Project:** The Biomass consultant, Spatial Informatics Group, has been issued a notice to proceed under their contract, and has begun work under Part A of the Study. Members of the Biomass Steering Committee attended a quarterly meeting of the CA Office of Planning and Research cohort of which the Marin Biomass Project is one of five.

• **Conserving Our Watersheds Program:** Equipment has been installed for the COW UDRS Bivalve project! COW CCAF Project 2022-02 is undergoing NEPA review. COW CCAF projects 2022-01 and 2022-02 bid documents are being drafted for fall 2022 implementation. COW CCAF deviation request (additional funds offered by SWRCB) is approved. Working with PRNS on Pond restoration of 10 ponds on 6 ranches fall 2022.

• Urban Streams Program: Sarah attended the annual Salmonid Restoration Federation's Coho Confab in September and has been busy providing lead organizational support for an upcoming Marin Creeks Symposium for practitioners. Sarah also carried out a series of site visits for private landowners in Mill Valley and in west Marin. Support was provided to Marin Water District with their juvenile salmonid monitoring efforts in Lagunitas Creek throughout the month. Sarah will be leading a training for 22 County staff members from Community Development Agency (CDA) to learn about hydrology, fluvial geomorphology, native and non-native riparian vegetation, and fisheries in west Marin (SGV and Lagunitas Creek).

• **Carbon Farming Program**: <u>State Coastal Conservancy</u>: Contracts are being developed with STRAW and UCCE. <u>Wildlife Conservation Board</u>: 4 CFP designs complete. Chileno Valley Ranch CFP underway. <u>Department of Conservation-Stemple Creek Restoration</u>: Fence materials have been delivered and installation has begun. Plant installation by STRAW scheduled for Fall 2022.

• Walker Creek Watershed: Designs are complete and are being reviewed by landowners and the Walker Creek Technical Advisory Committee.

- Funding Opportunities:
  - CARCD has been awarded for a monarch/pollinator/Carbon Farming grant from the CA Wildlife Conservation Board. Marin RCD is a recipient of this grant.
     \$221,000-\$450,000 (Awarded!)
  - USDA Climate Smart Commodities Program. \$2M (Awarded, negotiating amount)

• **Finance Committee:** Met and reviewed the Marin RCD audit presented for approval at this meeting.

• **District:** On boarding staff has been exciting. Staff are working on setting up grant management systems for the new Fiscal Year. Staff continue to develop the FY2223 Budget to include all new sources of funding. Per Board request at our last meeting, to meet in person in October, staff has been researching various local locations to host the meeting.

• **New landowners/stewards assisted:** Urban: 6 site visits, 9 landowners were assisted with information and 27 landowners and/or partners were educated. Agriculture: 5 land

managers were provided with funding information; 3 landowners were supported with CEQA compliance and PRNS ranches were provided support with Residual Dry Matter monitoring. Carbon Farming: 4 land managers were given technical assistance.

Project Updates: 20 min

• Review of Wildlife Conservation Board Project Designs – Preston Duncan, Marin RCD and Isaiah Thalmayer, Point Blue STRAW presented the preliminary designs for SoMar and True Grass and asked the board for input. Implementation will potentially take place next year.

Partner Updates:

- Marin Agricultural Land Trust/SAP Scott Dunbar informs the Board that their new ED, Lily Verdone, has started in her new position. He also shares that MALT has hired Acquisition staff. In regards to funding, MALT still has \$50,000 available in their DRAWS program after committing \$300,000. The MALT SAP program is still available for requests.
- **Point Blue & Students & Teachers Restoring a Watershed** Isaiah Thalmeyer shares with the Board that STRAW has a busy fall ahead of them with 90 days of working with students scheduled. He invites the Board to come out and see the planting in action! He also shares that Point Blue has just hired a fully paid group of Interns to work with Point Blue/STRAW for a year (a full cycle of seasons). Isaiah also shares STRAW is wrapping up the maintenance season to start planting in October.

 NRCS – Chris Howington shares with the Board that NRCS has obligated funds to 10 Marin County producers (\$655,000) in the FY22 with three more on the way. He states the final numbers will come at a later date. He also states the District Conservationist interviews have been completed and will hopefully be announced at the next Board meeting. Chris goes on to invite RCD staff to attend a prescribed training class Kristan Norman will be hosting this fall/winter. Chris also informs the Board that he will be leaving the Petaluma office to take a job in San Francisco. He introduces Veronica Rivera who is the new Senior Soil Conservationist. Veronica shares she has been with NRCS for six years working in Puerto Rico, Pennsylvania and Stockton, CA.
